Official Notice: Immunization Requirements for East Central University Students

Beginning Fall semester, 2004, Oklahoma state law (70-1210-193) required that all students who attend Oklahoma colleges and universities provide proof of immunization for certain diseases. If you cannot verify your immunizations you will need to be re-immunized. Medical, philosophical, religious, and moral exemptions are allowed by law and such requests must be made in writing at the Student Health Services office. You also may submit your immunization records online at healthservices@ecok.edu.

Immunizations Required by Oklahoma State Law

<u>Vaccination</u>	<u>Who must comply</u>	<u>Compliance Requirements</u>	<u>Compliance Data</u>
*Meningitis	All new students living in campus housing	Proof of vaccination	At enrollment
Measles, Mumps, Rubella, TWO DOSES	All new students born after January 1, 1957	Proof of vaccination with 2 doses of vaccine; or lab test demonstrating immunity; or, signed <i>Certificate of Exemption</i>	At enrollment
Hepatitis B	All new students	Proof of completion of a Hep B series or signed <i>Certificate of Exemption</i>	At enrollment
**Tuberculosis Skin Test	All new international students	Proof of negative test results in the United States	If test result positive, must have chest x-ray verification that student does not have TB

*No immunization record required for online-only students.

***Specific information regarding immunization for meningitis:** Oklahoma law (70-1210-193) requires that first time enrollees who reside in **on-campus student housing** be vaccinated against meningococcal disease **UNLESS:** 1) the individual signs a written waiver that he/she has reviewed the information provided by ECU regarding meningitis immunization and has chosen not to be immunized or, 2) in the case of a minor, the individual's parent or legal guardian signs the waiver.

**** Specific information regarding TB skin test:** the Oklahoma Health Department requires that TB testing be conducted in the United States (NO exceptions). The ECU Student Health Services can provide testing for you prior to your enrollment or it can be completed at any Oklahoma County Health Department.

All required immunizations are available at Pontotoc County Health Departments
