- brain development

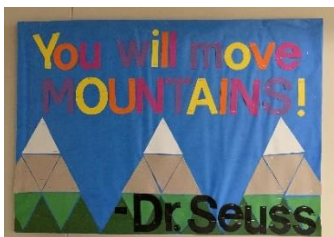

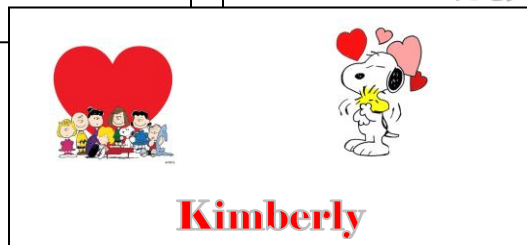
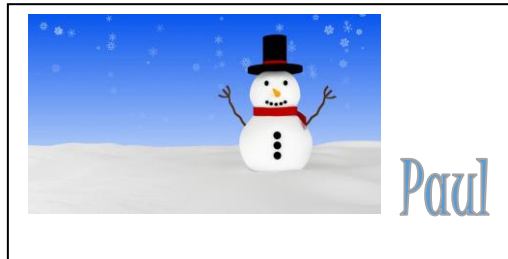

Laminating is FREE! You are welcome to come do it yourself or let us do it for you. You can email what you want laminated or drop it by to us.

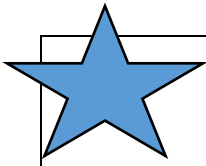

Notes from your Stars Outreach Specialist

Positive Teacher-Child Interactions

"Research indicates the ways teachers interact with children is crucial in determining how children develop over time." (Curby and Brock, 2013).

Every time an early childhood teacher and a child interact it is an opportunity to build a positive relationship. A child that feels connected to their teacher will view the classroom as a safe learning environment. A child who has negative interactions with their teacher will view the classroom as an unsafe learning environment.

Some things we know from research about positive teacher-child relationships:

- They help children develop secure relationships with other adults.
- They help children develop good peer relationships.
- They influence a child's social and emotional development.
- They reduce the frequency of behavior problems.
- They help children develop positive self-esteem.

Some simple but effective ways to nurture relationships:

- Nonverbal gestures such as a warm smile, a wave hello, or a reassuring touch
- Greet each child at the door by name
- Use a calm tone of voice and body language that welcomes the child
- Recognize children's temperaments as well as their likes and dislikes
- Have back and forth conversations with children about things that interest them
- Acknowledge a child's effort
- Tell the child how much he or she was missed when the child misses a day
- Read a child's favorite book to the whole class

PROPOSED QRIS (STARs) CHANGES

The QRIS requirements are part of Oklahoma Administrative Code and any changes to our QRIS criteria must go through this process, including Governor approval. While our effective date is pending, here is a broad look at what we can share at this time:

Background:

- The QRIS changes were designed by the QRIS Standing Subcommittee, a group of child care providers representing all types of licensed child care programs in Oklahoma and CCS staff.
- This group was very thoughtful to conduct extensive research and obtain input from stakeholders.
- The QRIS Standing Subcommittee had several goals as they worked on this restructure: increase provider participation and commitment to continuous quality improvement, simplify paperwork process, develop criteria that can be monitored, change to a five level system, and no or low cost to the child care industry.

Major Changes will include and address:

- Five level system
- Alternate pathway to national accreditation
- Continuity of care
- Master teacher graduated ratio
- Staff retention • QRIS Orientation training
- Curriculum and lesson planning
- Transitions
- Family partnership
- Professional development

- Online application
- Financial incentives
- Coaching services
- Training videos
- ECE business training and assistance

JANUARY-MARCH TRAINING OPPORTUNITIES

Most are **FREE** or have only a small registration fee.

You must pre-register for all training at www.okregistry.org. Please register early to prevent the class from being cancelled for low registration numbers. We have had to cancel several trainings because of lack of participation. Participants will be notified if the class is cancelled for any reason.

Safe Sleep Training

Our Infant Toddler Specialist, Lindsay Christian, and Child Care Consultant, Georgiana Sullivan, are certified Safe Sleep trainers and would be happy to come to your facility or a facility near you to provide this formal training. Contact either of them if you are interested. Also, several Self-Paced Web Based courses are available to meet the Oklahoma Child Care Services-Licensing requirement for safe sleep training. See the CECPD website for a full list of options and descriptions. The link to register may be found at www.okregistry.org.

ELG Training

Two Self-Paced Web Based ELG trainings are being offered by CECPD. Both are fourteen hour courses and the cost is \$20 for each. One is for Infants, Toddlers and Twos and the other is for Children Ages 3-5. These will meet the Oklahoma Child Care Services licensing requirement. Other Formal Training

We have no scheduled trainings at this time. However, Georgiana has three prepared to deliver upon request and can develop others covering topics relevant to your needs. The three approved and ready to be delivered are Room Arrangement, Circle Time and Building Positive Relationships with Children. If you have specific training needs or would like to have these specific topics presented, contact her so that she can get approval to offer a session. Trainings can be offered in your area.

The Scholars Program-What is it? Scholarships are available to eligible child care professionals completing coursework in the area of child development or early childhood education, as well as, the Child Development Associate (CDA) and Certified Childcare Professional (CCP) Credential Assessment. These scholarships are designed to enable child care providers in Oklahoma to improve their skills through education, receive an educational stipend, and continue the availability of quality child care in local communities.

Stipends are available through the Scholars for Excellence in Child Care Program and are valued from \$800-\$1200 for eligible scholars. Credentials can be earned toward CDA, CCP, CoM, SACoC, DCoC, DCom, and Associate Degree or Bachelor's Degrees. More than one stipend may be earned.

ARE YOU GETTING YOUR MONTHLY EMAILED COPY OF THE DHS CHILD CARE SERVICES NEWSLETTER? Much of the information previously shared via individual emails to providers is now being compiled into a monthly newsletter sent to you by OKDHS. Watch your emails for these important publications. If you are not getting the newsletter, be sure to sign up.



A Message from the Office of Background Investigations (OBI) October 19, 2021

Individual Notices:

- OBI is updating our systems.
- Due to these updates, QE's with CHRRP Portal access may now find Individual Notifications in your Portal results.
- No action is required for the program on these notifications.
- OBI sends the Individual notice to the individual's home address by USPS.
- However, if an individual states they have not received the Individual notice from OBI and/or moved shortly after submission of the background check request, the QE may share the Individual notice with the individual.

5 year rechecks:

- Don't panic, we have plenty of time! 😊
- The first 5 year re-assessments are not due until **November 1, 2022!**
- The first 5 year re-assessments will only be required for individuals who have been working in the same program for 5 years, since November 1, 2017.
- OBI is not accepting any 5 year rechecks/reassessments at this time.
- 5 year rechecks will be required to be submitted to OBI as a "5 Year Recheck", request type.
- A child care employment background check request will not be counted as a 5 year recheck.
- If you have changed programs, within a 5 year window-you have already had your criminal history re-assessed; and your 5 year recheck clock starts over.
- OBI will contact the industry in the summer of 2022, with instructions to begin submitting 5 year re-assessments—several months before the deadline.
- Programs that are anxious to be prepared for these rechecks, may prepare a list of staff that will require a 5 year recheck in November 2022 or thereafter.
- Remember, the very first 5 year rechecks will only be required for individuals that have been at the same program-without a break in employment-from November 1, 2017 through November 1, 2022.

Incomplete submissions:

To assist OBI in returning background checks timely, please:

- Please double check all Background Check Requests for accuracy, before submitting the request.
- Verify that the individual's current legal name is listed and spelled correctly.
- Verify that all names/aliases the individual has used during their lifetime, are listed and spelled correctly.

- Ensure that dates of birth and Social Security Numbers are entered correctly.
- Include information on any state the individual has lived in, or currently lives in, during the last 5 years.
- Remember that not only is this information required to conduct a comprehensive background check, but omitting required information for a background check could result in the individual being prohibited from employment.

A Message from the Office of Background Investigations (OBI) November 3, 2021

The Office of Background Investigations (OBI) has been conducting survey audits of all Qualified Entities (QE). The purpose of the survey is to verify compliance with QE standards as outlined in the Guide to Background Investigations. This audit is being conducted in phases by program type. We are currently in the process of sending Surveys to all Child Care Centers, however, we are preparing for the next phase of Child Care Homes.

OBI's QE Specialists are emailing the authorized recipient of each program a copy of the Guide to Background Investigations, as well as, the attached Non-Criminal Justice (NCJ) Security Awareness Training and NCJ Signature form. After a 2019 FBI audit, it was determined that all owners, authorized recipients, employees and household members with access and review are required to complete the NCJ Training to comply with QE standards. The NCJ Security Awareness Training is required to be completed every two years and failure or refusal to complete the training may result in termination of your program's QE status. If not already done so, required individuals of your program should review the NCJ Security Awareness Training. Sign and return the NCJ Signature form to OBI as soon as possible to verify compliance.

Dear Friends,

As we continue the Covid journey, I realize many of you may be overwhelmed and understaffed. Please know that CECPD is here to assist you in your professional development efforts. The following information will keep you up-to-date on a few upcoming changes:

On October 4, 2021, the Oklahoma Registry began sending incomplete letters for the Professional Development Ladder (PDL) and the Oklahoma Director's Credential (ODC) **VIA EMAIL. Paper letters are no longer be mailed to the participant.** It is crucial that you check your email regularly for communication from the Registry. You can log into your Registry account and read the notes regarding your application. If you require a paper letter to be mailed, please contact the Registry staff.

Be sure you have access to the email address listed on your Registry account. If you need to change your email address, you will find instructions on the CECPD website (www.cecpd.org). If you cannot update your email, personal information, or employment on your Registry account, please submit a complete **Participant Update Form** via email, fax or mail. Registry staff will update information as requested.

To locate the **Participant Update Form** go to www.cecpd.org under Provider Programs, Oklahoma Registry Information, Form. The form must include your name (first and last), last five digits of your social security number, date of birth, and signature with date, along with any information that needs to be updated. We cannot use forms that are missing the necessary information.

If you do not receive email communication for the Registry, please check your junk or spam folders. Please add no-reply@okregistry.org as a Safe Sender in your email.

CECPD Stipend Program Opportunity

The Center for Early Childhood Professional Development (CECPD) Oklahoma Registry Certificate of Achievement and Stipend Program awards \$600 to individuals who qualify when they meet professional development in specific areas of concentration.

Be on the lookout after the first of the year for two additional stipend opportunities to be included. These will include **Business Practices for Family Child Care Homes** and **Physical Activity and Nutrition**.

- Quality Child Care
