

2024-2025 Verification Worksheet Federal Student Aid Programs (Group V1)

Your FAFSA was selected for review in a process called "Verification." In this process ECU is required to compare information from your FAFSA with information from the IRS data match or IRS Tax Return Transcript for you and your spouse (if applicable). If you and/or your spouse were not required to file a federal tax return you must submit copies of any W-2 forms or earnings statements and a Statement of Non-Filing from the IRS. The law says we have a right to ask you for this information before awarding federal aid. If there are differences between your FAFSA and your financial documents we will make necessary corrections to your FAFSA information.

What you should do

- O Complete this worksheet. ALL SECTIONS MUST BE FILLED IN. Write N/A (not applicable) or enter a zero if the field does not pertain to you. You and your spouse (if applicable) MUST sign the worksheet.
- O Send or take the completed worksheet, plus copies of your 2022 IRS Tax Return Transcript and 2022 W-2 forms (if applicable below) to the Financial Aid Office at East Central University.

We must review the requested information under the financial aid program rules (CFR Title 34, Part 668).

Individuals Granted a Filing Extension by the IRS

An individual, who is required to file a 2022 IRS income tax return and has been granted a filing extension by the IRS, must provide:

- A copy of IRS Form 4868, "Application for Automatic Extension of Time to File U.S. Individual Income Tax Return," that was filed with the IRS for tax year 2022;
- A copy of the IRS's approval of an extension beyond the automatic six-month extension if the individual requested an additional extension of the filing time for tax year 2022;
- Verification of Non-filing Letter (confirmation that the tax return has not yet been filed) from the IRS or other relevant tax authority dated on or after October 1, 2023;
- A copy of IRS Form W–2 for each source of employment income received for tax year 2022 and,
- If self-employed, a signed statement certifying the amount of the individual's Adjusted Gross Income (AGI) and the U.S. income tax paid for tax year 2022.

Individuals Who Filed an Amended IRS Income Tax Return

An individual who filed an amended IRS income tax return for tax year 2022 must provide:

- A 2022 IRS Tax Return Transcript (that will only include information from the original tax return and does
 not have to be signed), or any other IRS tax transcript(s) that includes all of the income and tax information
 required to be verified; and
- A signed copy of the 2022 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS.

Individuals Who Were Victims of IRS Tax-Related Identity Theft

An individual who was the victim of IRS tax-related identity theft must provide:

- A Tax Return Database View (TRDBV) transcript obtained from the IRS, or any other IRS tax transcript(s) that includes all of the income and tax information required to be verified; and
- A statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related identity theft.
